1. Permit application as applicable, to be filled out and left with required items for Building Department Review.
2. Current copy of Liability and Worker's Compensation Insurance Certificates for contractors must be on file in the Building Inspector's Office.
3. All Building & Structures on site shall be removed.
4. Certification of:
 - Termination of electric, gas, water (termination at main)
 - ACM Report or Asbestos abatement
 - Notification Water Department (355-7575 Ext 395)
 - All building materials, including the entire foundation, shall be disposed of at an approved sanitary landfill. Provide Documents.
 - All underground storage containers (i.e. septic, oil tanks, gas tanks) shall be removed
5. Provide current copy of Property Deed.
6. **Except as hereinafter provided, no person, firm, corporation, association or partnership shall commence the construction, enlargement, alteration, improvement, removal or demolition of any building or structure or any portion thereof, or any land activity or development or install a solid fuel-burning heating apparatus, chimney or flue in any dwelling unit without first having obtained a permit from the Building Inspector/Code Enforcement Officer of the Town of Rotterdam.**
